*The Building Department may charge an additional fee for permits and inspections of generators and associated wiring for amusement device events. Generators subject to these fees are those exclusively with amusement devices and that are inspected by the Grayson County Building Department. The fee per event shall be a minimum of \$60.00 not to exceed \$165.00.

Exception: Small portable generators serving only cord and plug connected equipment loads shall not be subject to the generator fees above.

IMPORTANT NOTES:

The permit application shall be made to the local building department at least five (5) days before the date in which the applicant intends to operate an amusement device.
