Kevin Spurlin, Grayson County Extension Agent addressed the Board and handed out a copy of the 2017 Census of Agriculture-County Profile and noted that it is available online. He did highlight that market value of products sold in Grayson County was almost \$41,000,000. Mr. Spurlin also noted that as of this census Grayson County is ranked #1 in Christmas tree farms; #7 in cattle/calves and #17 in sheep/goats/wool/mohair/milk. Update on the GATE Center as follows:


