• Resolution – Emergency Operations Plan

Mr. Paul Hoyle, Emergency Services Director, addressed the Board and explained there were some inconsistencies in wording in the Emergency Operation Plan and after looking at the plan word-for-word, he's recommending the following changes:

- On page 8, change wording <u>from</u>: Director of Emergency Management The Director of Emergency Management shall be a member of the Board of Supervisors or the County Administrator..... <u>to</u> Director of Emergency Management The Director of Emergency Management shall be the Chair of the Board of Supervisors.....
- On page 30, change wording <u>from</u>: Grayson County Coordinator of Emergency Management <u>to</u> Grayson County Emergency Management Coordinator.

Mr. Hoyle noted this resolution was approved at the last meeting (June 10, 2021) and Mr. Hoyle has just updated the wording in the Emergency Operations Plan. Mr. Smith noted the resolution that was passed last month satisfied the State.

IN RE: NEW BUSINESS

• Resolution – Grayson County Emergency Services

Mr. Hoyle noted this is the same resolution that was presented to the Board last year and there are three (3) major reasons for the need of the resolution with the goal to have the County licensed as a non-ems transport agency which are:

- (1) Allows us to have a County-wide operational medical director which would allow consistency between medical protocols and all agencies
- (2) Logistics currently Mr. Hoyle can't assist the agencies in purchasing medical equipment (currently can purchase non-medical equipment like masks/gloves) since we don't have an operational emergency director currently a physician is required to sign off on the purchase of medical equipment this resolution

- would meet that guideline plus both these (#1 & #2) would meet part of our strategic plan
- (3) It's inappropriate for Mr. Hoyle to affiliate with any one agency to practice medicine in the County, he can't practice medicine even though he's a paramedic by acquiring an EMS license, that would allow him under conditions of a true emergency (ex: where no one else is available), he could respond to the call all this came about due to an incident that arose with someone choking and an ALS provider within 30 minutes Mr. Hoyle would like to be able to help as a last resort in extreme situations.

This resolution is a prerequisite to applying to the state for an EMS license — they require the governing body approve the resolution. Supervisor Fant inquired about preventing conflicts with other agencies and Mr. Hoyle responded that would be done through policies. Mr. Shepley read the resolution (listed below). Supervisor Hash made the motion to approve; duly seconded by Supervisor Fant. Roll call vote as follows: Brenda R. Sutherland — aye; John S. Fant — aye; Thomas R. Revels — aye; Michael S. Hash — aye; Kenneth R. Belton — aye. Motion carried 5-0.
